**enter into according to the provisions of Section 2055 et seq. of Act No. 89/2012 Coll., the Civil
Code, as amended, the following**

**Gift Agreement
hereinafter referred to as the “Agreement“**

I. Subject of the Agreement

- 1. The Donor hereby hands over to the Donee a free voucher at face value of CZK 1,000, CZK 2,500 or CZK 5,000. This is always limited to only one voucher per person, depending on the selected services. Legal entities cannot be issued a voucher.**

II. Conditions of voucher use

- 1. The voucher may be used on the basis of prior direct and prepaid reservation of accommodation services in Karlovy Vary that are provided by entrepreneurs participating in VARY VOUCHER by 30 September 2020. The list of entrepreneurs engaged in the VARY°VOUCHER system is published at www.karlovyvary.cz/cs/voucher**
- 2. Individual types of vouchers may be used as follows:**

Bed & Breakfast Voucher at face value of CZK 1,000 incl. VAT, which can be used to book “bed and breakfast stays” for a minimum of 3 nights and minimum total reservation value of CZK 3,000 incl. VAT

Wellness Voucher at face value of CZK 2,500 incl. VAT, which can be used to book “wellness stays” for a minimum of 4 nights and minimum total reservation value of CZK 9,000 incl. VAT, where a wellness stay means a service package containing accommodation provided with at least breakfast and including other hotel wellness services, such as massages, free baths, free admission to the swimming pool, etc.

Spa Voucher at face value of CZK 5,000 incl. VAT, which can be used to book spa stays for a minimum of 7 nights and minimum total reservation value of CZK 19,000 incl. VAT, where a spa stay means accommodation with at least half-board and a package of spa procedures provided by a non-state health facility (properly accredited) on the basis of a prescription issued by the spa physician.

III. Business terms and conditions

Other conditions of the VARY VOUCHER project are defined by the General Terms and Conditions, published at www.karlovyvary.cz/cs/voucher, which are hereby acknowledged by the Donee.

IV. Final provisions

This Agreement comes into force and takes effect on the date that a voucher is generated.
